LATAM Airlines Group S.A (LTM) will change its trading symbol to LTMAQ effective June 10, 2020, due to the listing of the company on an OTC market. As a result, option symbol LTM will change to LTMAQ effective at the opening of business on June 11, 2020.

Strike prices and all other option terms will not change. Clearing Member input to OCC must use the new option symbol LTMAQ commencing June 11, 2020.
